YES <input type="radio"/> NO <input type="radio"/>	<b>DELTA COUNTY 911 MILLAGE PROPOSAL</b>  To renew the authorization expiring after the December 1, 2014 levy, shall the previously voted increase in the tax limitation imposed under Article IX, Section 6 of the Michigan Constitution on the amount of taxes which may be imposed by the County of Delta against real and tangible personal property in the County be increased by up to three quarters of one mill (\$0.75 per \$1,000.00 per taxable valuation) on the taxable value of such property for a period of Five (5) years, beginning with the December 1, 2015 tax levy, inclusive, for the purpose of providing funds for the equipping, furnishing, and operating the Delta County 911 Emergency telephone answering and dispatch system, and shall the Delta County Board of Commissioners be authorized to levy such millage for this purpose?
