JUSTICE OF SUPREME COURT Vote for not more than 1	SHERIFF'S BOND PROPOSAL MILLAGE Shall the County of Delta, Michigan, borrow the principal sum of not to exceed Seventeen Million Nine Hundred Thousand Dollars (\$17,900,000) and issue its general obligation unlimited tax bonds payable over a period not to exceed thirty (30) years from date of issuance, to be used by the County for the purpose of paying the costs of construction, equipment, and site improvements of a Sheriff's Office and Corrections Center? The estimated millage to be levied in 2017 is 0.85237 mills (\$0.85237 per \$1,000 of taxable value) and the estimated simple average annual millage rate required to retire the bonds is 0.85175 mills (\$0.85175 per \$1,000 of taxable value).
