Moved by Commissioner Schultz and seconded by Commissioner Ruohomaki to recommend authorizing Administrator Erickson and Building and Zoning Director Carviou to set up a "Fee for Service" for the County to provide zoning for townships and to notify the townships of the County's intentions. MOTION CARRIED.

Moved by Commissioner Schultz and seconded by Commissioner Rivard to recommend that the new color copier for MSU Extension be included in their budget to be taken out of the equipment line item. MOTION CARRIED. (Bengry Opposed).
