1. Presentation and Tour of Pioneer Trail and Fuller Parks with the Parks and Recreation Advisory Board and the Delta Conservation District.

Rory Mattson, Director Delta County Conservation District, gave a presentation on Pioneer Trail Park, Fuller Park, Sac Bay, Rapid River Falls Park and Fish Dam properties. Infrastructure upgrades completed and recommended were presented including electrical and campsite upgrades, adding campsites and moving tent sites, fixing pavilion and possible additional pavilion with kitchen facility, new playground equipment, picnic tables and grills at Pioneer Trail Park; adding 12 new 50 amp/water sites in picnic area, eliminating poison ivy, improving beach area at Fuller Park, partnering with groups to build campsites for an ORV park at Rapid River Falls Park; eventual rough camping sites at Sac Bay.
