2. Prosecutor.

Steve Parks requested an additional \$2,500 to be added to his budget, bringing it to \$530,245. Moved by Commissioner Rivard and seconded by Commissioner Harrington to increase the Prosecutor's 2014-15 budget by \$2,500 in the requested line items. MOTION CARRIED.

3. Circuit Court.

Judge Davis requested that Circuit Court be funded at the same amount as last year \$338,950. Moved by Commissioner Rivard and seconded by Commissioner Harrington to recommend funding Circuit Court at \$338,950. MOTION CARRIED.

4. MSU Extension.

The annual appropriation was discussed by Jim Lucas and he requested a \$50,000 appropriation. Commissioner Jousma-Miller provided usage figures for various programs. Commissioner Harrington requested an expenditure breakdown of the annual appropriation. Commissioner Rivard felt that the Board was being unfair and demanded that all other organizations getting a County appropriation provide the same information.

Chairman Elegeert discussed the need to move the Extension Office due to the shut down of the heating and cooling for half the Service Center Building
