

A Regular Meeting of the Board of Delta County Road Commissioners was held on Tuesday, April 13, 2021 at 4:30 p.m. at the Main Office, 3000 32nd Avenue North, Escanaba, Michigan. The Board Meeting was accessible to the public via GoToMeeting Conference Call.

Chairman Aschbacher called the meeting to order at 4:30 p.m., followed by the Pledge of Allegiance.

Grading on the gravel roads began this week and the crew is trying to get to as many roads as possible since it has been difficult with all the rain we have been getting. The Wells garage is currently being torn down. Manager Norman briefly discussed the ongoing deer and snowmobile issue. We will be getting a letter of support from Rory Mattson and the County regarding the deer issue with road killed deer being dumped on Delta County property.
